

FACTS PERTAINING TO EXPUNGEMENT MATTER

1. Petitioner was EITHER 'ARRESTED' OR 'SUMMONED' in COUNTY WHERE THIS IS FILED County on DATE ARRESTED by NAME OF THE ARRESTING OFFICER, IF YOU KNOW IT.
