## STEP 1: FINISH, READ AND SIGN THE FORMS

- 1. Check your county's local rules here: <a href="https://www.in.gov/judiciary/2694.htm">https://www.in.gov/judiciary/2694.htm</a> to see if there are additional things you need to include on your forms, or to bring with you to court.
- 2. Read the <u>Appearance</u> and make sure the information is correct. Fill in the date on the Certificate Of Service with the date you send/deliver the form to the other parent. Sign the form.

- 3. Read the <u>Verified Petition To Establish Parenting Time Without An Agreement</u> and make sure the information is correct. Complete the Certificate of Service and sign the form, just like on the <u>Appearance</u>.
- 4. Read the <u>Order Setting Hearing</u> and the <u>Order Establishing Parenting Time</u> and make sure the information is correct. <u>DO NOT SIGN THESE FORMS</u>.

- The <u>Order Setting Hearing</u> will be filled in the by the court and used to tell you when the hearing will be (when you will go to court).
- The Order Establishing Parenting Time is what the judge is asked to sign. The judge may or may not sign it. It is not an order from the court if it is not signed by the judge.
- 5. Complete a Child Support Worksheet. You will need to bring the worksheet to court with you. You can find the child support calculator that creates the worksheet at: https://www.in.gov/judiciary/2625.htm
- 6. Review the Indiana Parenting Time Guidelines. At the hearing you will need to tell the judge whether you think the other parent should have parenting time according to the Indiana Parenting Time Guidelines or if they should have parenting time that is different from the guidelines. You can find the guidelines here:

## STEP 2: FILE THE FORMS WITH THE COURT

People who are self-represented (do not have a lawyer) can choose to e-file forms, or to file them at the courthouse. Read the information below and then choose how to file the forms with the court.

#### OPTION ONE: E-FILING DOCUMENTS WITH THE COURT

- 1. Review and follow the instructions in the e-file user guide at: https://www.in.gov/judiciary/4313.htm.
- 2. Make sure you get the forms to the other parent using the method selected in the Certificate of Service (usually hand delivery or mail) after you e-file them with the court.

  The e-filing system will not send them to the other parent unless the other parent (or their attorney) has registered with the e-filing system—this is not common if the other parent does not have an attorney.

#### OPTION TWO: FILING DOCUMENTS WITH THE COURT IN PERSON

- 1. Take the original, signed forms and the completed Child Support Worksheet to the courthouse in the county in which the last order on custody was issued.
- 2. Give your completed documents to the court clerk and ask them to file your forms with the court.
- 3. Make sure you get the file stamped forms to the other parent using the method you selected (usually hand delivery or mail).

# **STEP 3: THE HEARING**

After you file the forms, the court will send an *Order Setting Hearing* that has been completed by the court.

- Go to the hearing at the date and time on the *Order*.
- Dress nicely.
- Do not bring your children.
- Bring a completed Child Support Worksheet and anything you believe shows that parenting time should start.
- Note that nothing is final until after the hearing when you have an *Order* signed by the judge.
