### GENERAL INSTRUCTIONS ON HOW TO ASK THE COURT TO MODIFY (CHANGE) PARENTING TIME WHEN PARENTS HAVE AN AGREEMENT AND HAVE NEVER BEEN MARRIED

### STEP 1: FINISH, READ AND SIGN THE FORMS

- 1. Check your county's local rules here: <u>https://www.in.gov/judiciary/2694.htm</u> to see if there are additional things you need to do.
- 2. Read the forms and make sure the information is correct.
- 4. You and the other parent should sign the <u>Verified Agreed Entry To Modify Parenting</u> <u>Time</u> in front of a Notary Public. You might find a Notary Public at a bank or library. There is a small fee.
- 5. Complete a Child Support Worksheet. A Child Support Worksheet should be filed with these forms. Find the child support calculator at: <u>https://www.in.gov/judiciary/2625.htm</u>
- 6. Review the Indiana Parenting Time Guidelines. Find the guidelines here: <u>https://www.in.gov/judiciary/rules/parenting/</u>

## **STEP 2: FILE THE FORMS WITH THE COURT**

People who are self-represented (do not have a lawyer) can choose to e-file forms, or to file them at the courthouse. Read the information below and then choose how to file the forms with the court.

#### **OPTION ONE: E-FILING DOCUMENTS WITH THE COURT**

- 1. Review and follow the instructions in the e-file user guide at: <u>https://www.in.gov/judiciary/4313.htm.</u>
- 2. <u>Make sure you get the forms to the other parent using the method selected in the</u> <u>Certificate of Service (usually hand delivery or mail)</u> *after you e-file them with the* <u>court.</u> The e-filing system will not send them to the other parent <u>unless</u> the other <u>parent (or their attorney) has registered with the e-filing system—this is not</u> <u>common if the other parent does not have an attorney.</u>

#### **OPTION TWO: FILING DOCUMENTS WITH THE COURT IN PERSON**

- 1. Take the original, signed forms and the completed Child Support Worksheet to the court that issued the last order in your case and is listed at the top of your documents.
- 2. Give your completed forms to the court clerk and ask them to file your forms with the court.
- 3. The Form Helper asked how you will get the forms to the other parent. <u>Make sure you get</u> <u>the file stamped forms to the other parent using the method you selected (usually</u> <u>hand delivery or mail).</u>

### **STEP 3: WAIT FOR THE ORDER**

1. Nothing is final until the judge signs an order, which may be the *Verified Agreed Entry To Establish Parenting Time*.
