That means you must show up to the scheduled hearing, unless the judge tells you that you can show up by dialing in on a telephone or through a virtual platform. You must go to the hearing unless the judge signs an <i>Order</i> saying you don't have to.

5.	Make three copies of each of these documents.
6.	Prepare three stamped envelopes. One should be addressed to you and two should be addressed to the other party.

8.	File your documents with the court clerk. The clerk will stamp your forms.
