- You may choose to file your documents in-person at the courthouse. **If you will file your paper documents at the courthouse, you will need to print them when you have finished filling them out. You can print by holding down the CTRL key and the “P” key on your computer at the same time.**

Appearance

- This is the document that tells the court how to contact you if they need to.

Response To Notice Of Intent To Relocate

- This is the document that tells the court how you want to response to the Notice Of Intent To Relocate that you have received.

Order Setting Hearing

- Only file this form if you want the court to hold a hearing. If you want the court to hold a hearing, make sure you tell the court you want a hearing when you file your Response To Notice Of Intent To Relocate by checking the box in section 3 that asks for a hearing.
